## Message From Executive Director of the Mississippi Department of Mental Health Ms. Diana Mikula



As you are all aware by now, this has been a difficult year for many agencies throughout the state, including the Department of Mental Health. When I last wrote to you, DMH was still examining the full impact of the budget reduction we received in our appropriations bill. The end result of that was a reduction in force and a reduction in services in some of our programs.

Despite the difficulties of the year, I want to make sure all DMH employees know how much your hard work is appreciated by people at all levels – from supervisors, to program directors, to everyone in administration, and most importantly, by the people DMH serves.

All DMH employees face unique challenges, and I know you are rising to meet those challenges every day you are at work. We are thankful you continue to work

for our agency and provide services to people living with mental illness, intellectual and/or developmental disabilities, and substance use disorders.

We are already preparing for the next legislative session, and will be presenting our Fiscal Year 2018 budget request in September. Just as in this past year, one of our top priorities will be requesting a salary realignment for our Direct Care employees. They have some of the hardest jobs in state government, and we want to support them by advocating for this realignment.

Our mission is to support a better tomorrow for all Mississippians, and that's what you all do daily. Our programs have received significant budget cuts since 2008. Despite that, we have continued to provide excellent services to those in need, and that is thanks to the work you accomplish as DMH employees. We have worked to share the importance of that work and the impact it has on people's lives with our legislators. I want them to know we are proud of the jobs you all are doing to help accomplish our mission.

As we move forward to our budget hearing and beyond, we will continue to share our mission with everyone we can. Remember that your voice matters. I hope you will take every opportunity to share it with others as well, including your own representatives and senators.

The coat you wanted me to send that you forgot here was too heavy to send in the mail. So we cut off the big buttons and put them in the pockets.

We got a bill from the funeral home, said if we didn't make the last payment on Aunty's funeral bill, up she comes.

I heard that Sis had a baby this morning but I haven't been over there yet to find out if it's a boy or a girl so I don't know if I'm an Aunt or an Uncle. Our neighbor up the road fell in the whisky vat. Some men tried to pull him out, but he fought them off playfully, so he drowned. We cremated him and he burned for three days.

Three local kids from DeBorgia went off the bridge in a pick-up truck. The one that was driving rolled down the window and swam out. The two sitting in the back drowned. They couldn't get the tailgate down.

Not much to tell this time. Nothin' much happens 'round here.

HIPAA regulations are complex and can mean different things to different areas within a single organization. Staff with access to Protected Health Information (PHI) should follow these general tips to help keep the information of the people we serve secure and prevent accidental disclosure to unauthorized staff, other individuals, family members or visitors:

Learn what sorts of information qualify as PHI, including the following:

Names, addresses and telephone/fax numbers Email addresses Social Security numbers File/Account numbers Dates of birth, death, admission and discharge Photographs and comparable images of the people we serve

- Access personal information only for valid reasons related to treatment, care, billing or record maintenance. Only access the information to the minimum degree that you need to do your job.
- Keep PHI out-of-sight and secure when not actively in use. Do not leave PHI unattended on workspaces or in storage areas.
- IF PHI must be transmitted via email, be sure to use secure, encrypted email. Contact the IT department if you are unsure if the email you send is encrypted. Never transmit PHI or any other confidential email using your personal email account.
- Use proper procedures when disposing of any material containing PHI. Remove labels or black out information on the label before throwing away pill bottles, vials or any other label containing PHI. Documents containing such information should be shredded and never recycled.

Keep computers secure:

- $\Rightarrow$  Do not share computer passwords or make them easy to guess
- ⇒ Always log off or lock your computer if you are going to be away from your desk
- $\Rightarrow$  Do not allow others to use a computer if another user is still logged on
- Avoid public conversation or discussion about the people we serve. This includes public areas within the organization itself, as well as in any area outside the organization.
- Do not post PHI or any other confidential information online.
- Make sure you understand what constitutes a breach and how to report a compliance issue or a suspected breach.
